(COLUMBUS, Ohio)-Following an evening briefing regarding the train derailment in East Palestine, Governor DeWine and Columbiana County officials are issuing an urgent warning to those living within a mile of the derailment. Within the last two hours, a drastic temperature change has taken place in a rail car, and there is now the potential of a catastrophic tanker failure which could cause an explosion with the potential of deadly shrapnel traveling up

## **East Palestine Update: Evacuation Area Extended, Controlled Release of Rail Car Contents**

(EAST PALESTINE, Ohio)— Following fumes into the new modeling information conducted this morning by the Ohio National Guard and U.S. Department of Defense, Ohio Governor Mike DeWine and Pennsylvania Governor Josh Shapiro are ordering an immediate evacuation in a one-mile by two-mile area surrounding East Palestine which includes parts of both Ohio and Pennsylvania.

The vinyl chloride contents of five rail cars are currently unstable and could potentially explode, causing deadly disbursement of shrapnel and toxic fumes. To alleviate the risk of uncontrollable shrapnel from an explosion, Norfolk Southern Railroad is planning a controlled release of the vinyl chloride at approximately 3:30 p.m.

According to Norfolk Southern Railroad, the controlled release process involves the burning

## **Ohio Governor Mike DeWine Week in Review**

On Monday, Ohio Governor Mike DeWine traveled to East Palestine to meet with local officials and emergency responders following the derailment of a Norfolk Southern Railway train. Governor DeWine activated the Ohio National Guard and sent personnel from the Ohio State Highway Patrol to assist local authorities. Governor DeWine conducted a press conference urging residents within a 1-mile by 2-mile area surrounding East Palestine to evacuate while the railroad company conducted a controlled release of chemicals

Also on Monday, the Ohio Department of Transportation (ODOT) announced applications for funding to develop and implement projects that enable and encourage children to safely walk or bike to

ODOT's Safe Routes to School (SRTS) program is funded at \$5 million annually, a \$1 million increase from last year. It provides funding for infrastructure improvements such as pedestrian and bicycle crossing improvements, new or improved sidewalks, and bike racks. It also helps fund non-infrastructure activities such as walk to school days, bike rodeos, public awareness campaigns, and educational programs.

"Ensuring that Ohio children get to school safely by walking and biking is just as important as ensuring safe travels in a school bus or car," said Governor Mike DeWine. "The additional funding provided to this program will allow more communities and schools to make routes between home and school safe, convenient, and ac-

Lastly on Monday, Governor DeWine released Ohio's Comprehensive School Safety Framework that outlines recommended



strategies that schools can use toward creating physically and emotionally safe environments for students.

"There is nothing more important than the well-being of our kids, and this framework outlines strategies that schools can implement to help ensure a safe learning environment and positive school climate," Governor DeWine said.
