Ohio Governor Mike DeWine Week in Review

Ohio Governor Mike DeWine, Lt. Governor Jon Husted, Ohio Department of Development Director Lydia Mihalik, and JobsOhio President and CEO J.P. Nauseef announced that Joby Aviation Inc. will build an electric air taxi manufacturing facility at the Dayton International Airport, creating 2,000 new jobs in the Miami Valley.

Joby Ohio's new assembly-line manufacturing facility will build, test, and fly all-electric, vertical takeoff and landing (eVTOL) air taxis that will predominantly be used for commercial passenger operations. The aircraft, designed to accommodate a pilot and four passengers, will be capable of achieving speeds of up to 200 mph over a 100-mile range. The corporation plans to operate the aircraft as part of aerial ride-sharing networks in cities and communities around the world.

"Ohio's legacy in aviation leadership begins with the Wright Brothers and continues now with Joby Aviation, as they launch a new era in advanced aviation manufacturing and aerial mobility in Dayton," said Governor DeWine. "The aircraft that will roll off Joby Ohio's production lines will redefine urban transportation and contribute to a transformational change in the way people and goods travel. We welcome Joby and celebrate the new chapter of air mobility history that will be made here in Ohio, the Heart of Aviation and

Today's announcement didn't come about by chance, it was earned through 20 years of strategic planning in the Dayton region, leading us to be in the best possible position for a company like Joby to expand their operations from California to Ohio," said Lt. Governor Husted. "Dayton has solidified itself as the center of aviation innovation, from the Wright Brothers to Wright-Patterson Air Force Base, but for over 100 years, that innovation has not been successfully translated into the manufacturing of aircraft and the thousands of jobs that come with it. Today, that elusive aspiration becomes reality.

Housed within the Ohio Department of Public Safety, the Central Ohio CGIC is operated in partnership between the Columbus Division of Police, Ohio State Highway Patrol, Ohio Narcotics Intelligence Center, Ohio Attorney General's Bureau of Criminal Investigation, and U.S. Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF). This centralized law enforcement hub, which focuses exclusively on investigating and preventing gun violence, combines the expertise of firearm evidence examiners, intelligence analysts, and investigators under one roof to rapidly collect, analyze, and share information about guns used in violent

"The new Central Ohio Crime Gun Intelligence Center represents the next generation in intelligence-based policing, and it is unlike anything that has ever been done in Central Ohio before,' said Governor DeWine. "The teams taking part in this large-scale and long-term collaboration are sharing everything from intelligence and investigative leads to technology and manpower so that they can zero in on the people who are shooting and killing others without remorse. Gun violence is about to become much, much harder to get away with in Central Ohio."

hio and dedicated to advancing the research and production of crucial microelectronics for the defense industry, was awarded regional hub designation and \$24.3 million for fiscal year 23 through the prestigious Microelectronics Commons (ME Commons) program. The foundation for this statewide collaboration was laid during the advocacy for the CHIPS Act in 2021 and 2022, and more recently, it has gained momentum as we seize the opportunities arising from Intel's \$20 billion investment in our

"This is a big win and serves as another opportunity for Ohio to take the lead in reshoring semiconductor production and securing vital defense and commercial microelectronics research and manufacturing," said Lt. Governor Husted. "With a focus on delivering the best solutions to our nation's warfighters and supporting our critical National Security Strategy, we are confident in our ability to both secure and expand America's leadership in the global microelectronics supply chain. It' s another step for Ohio to help America advance our economic and national security."

Governor DeWine and Lt. Governor Husted announced that the Ohio Board of Building Standards recently adopted the 2024 Ohio Building (OBC), Mechanical (OMC) & Plumbing Codes (OPC) rules, a process that resulted in the removal of duplicative and unnecessary language in these codes and decreases the number of words in the Ohio Administrative Code by over 610,000, ultimately making it easier for businesses to comply.

'As businesses continue to thrive and grow in Ohio, the updated building codes come at a perfect time," said Governor Mike DeWine. "The Board of Building Standards is making it easier for businesses by not only removing unnecessary and duplicative language but also by including new technologies and materials used in construction today.'

'When we set out on our mission to eliminate one-third of the OAC, our goal was to make it easier for people and businesses to comply - saving people time and money," said Lt. Governor Husted. 'Streamlining Ohio's building code was a big part of this effort. Additionally, through passage of the recent budget, we are now able to work with the Lottery Commission to delete up to 1.7 million unnecessary words related to individual lottery game procedures. We have also identified an additional 2.3 million words of duplicative and unnecessary regulatory text established by individual higher education institutions. This initiative is a great example of common-sense regulatory reform, which ultimately makes our state more attractive for new business growth.'

Governor DeWine and the Ohio Department of Development announced three communities will receive a total of \$2.25 million in Residential Public Infrastructure Grant funding for improvements to their wastewater treatment facilities.

The grants, funded through the federal Community Development Block Grant, will help these communities improve the quality of life for more than 1,300 Ohioans by providing safe and reliable drinking water and proper disposal of sanitary

"Access to clean water and reliable infrastructure is not just a basic necessity, it is the heart of any thriving, healthy community," said Governor DeWine. "Through these investments, we're not only safeguarding our environment, but also enhancing the quality of life for our residents.

The projects announced today will benefit Ohio families living in these communities and ultimately makes these regions more attractive for economic growth," said Lt. Governor Husted. "Infrastructure is the backbone of economic development, leading to increased productivity, job creation, and improved quality of life.'

Governor DeWine, Lt. Governor Husted Announce New Projects Expected to Create More Than 300 Jobs, \$27 Million in Payroll

(COLUMBUS, Ohio)—Ohio Governor Mike DeWine and Lt. Governor Jon Husted today announced the approval of assistance for six projects set to create 332 new jobs and retain 926 jobs

During its monthly meeting, the Ohio Tax Credit Authority (TCA) reviewed economic development proposals brought to the board by JobsOhio and its regional partners. Collectively, the projects are expected to result in more than \$27 million in new payroll and spur more than \$426 million in investments across Ohio.

Projects approved by the TCA include: CENTRAL

G & J Pepsi-Cola Bottlers, Inc. (Franklin County) expects to create 44 full-time positions, generating more than \$2.2 million in new annual payroll and retaining \$30.6 million in existing payroll, as a result of the company's expansion project in the city of Columbus. G & J Pepsi is a full-service contract beverage producer, bottler, distributor, and marketing firm for more than 30 brands.

The TCA approved a 1.171%, six-year Job Creation Tax Credit for this project. SOUTHWEST

Curiosity, LLC (Hamilton County) expects to create 32 full-time positions, generating \$3.4 million in new annual payroll, and retaining \$6,103,496 in existing payroll, as a result of the company's expansion project in the city of Cincinnati. Curiosity is a marketing firm specializing in brand strategy development, social media, advertising, and digital marketing. The TCA approved a 1.633%, seven-year Job Creation Tax Credit for this project.

Dine Development Corporation; DDC IT Services, LLC; Dine Source LLC (Montgomery County) expects to create 100 full-time positions, generating \$12 million in new annual payroll, and retaining \$22 million in existing payroll, as a result of the company's expansion project in the city of Dayton. DDC delivers IT, professional, and environmental services to government agencies and commercial firms. DDC has a broad span of IT services includ-


ing data enablement, data science, cloud adoption, cybersecurity, and modern software design. The TCA approved a 2.178%, nine-year Job Creation Tax Credit for this project.

NORTHEAST

Ohio Ordnance Works, Inc. (Lake County) expects to create 70 full-time positions, generating \$3.9 million in new annual payroll, and retaining \$5,542,814 in existing payroll, as a result of the company's expansion project in the city of Chardon. Ohio Ordnance Works is a manufacturer of firearms and ordnance for supply to different foreign and domestic government agencies. The TCA approved a 1.226%, six-year Job Creation Tax Credit for this project.

Aligned Data Centers (NEO) Propco, LLC (Erie County) ex-

pects to create 18 full-time positions, generating \$1.6 million in new annual payroll as a result of



68 full-time positions, generating \$3.6 million in new annual payroll, as a result of the company's new location in Shalersville Township. Viega develops, manufactures, and sells plumbing, heating and pipe connection products and other products for heating and cooling systems and drainage technology. The TCA approved a 1.325%, eight-year Job Creation Tax Credit for this project.
