華府 — 美國國稅局今天提供了一份清 單,來幫助正準備在報稅季提交 2023 年 税表的納稅人。

這六個簡單的提示能使 2024 年的報稅 *兼職或季節性工作。 工作更加順利。大部分信息也可在 IRS.gov 上的免費幫助特殊頁面上找到:

1. 收集所有必需的稅務文件和記録以 確保準確性,從而避免錯失扣除或抵免(英 文)。納稅人在準備稅表之前應準備好所有重 要且必要的文件。這將有助于提交完整且準 確的稅表。錯誤和遺漏會減慢稅務處理速度, 包括退稅時間。

在開始之前,納稅人應該有:

- * 稅表上列出的每個人的社會安全號碼。
- *銀行機構識別碼和賬戶號碼。
- * 各種稅務表格, 例如 W-2、1099、1098 和其 它收入文件或數字資産交易記録。
- *表格 1095-A,健康保險市場聲明。
- *任何國稅局信函,注明某特定稅務扣除或抵 免所收到的金額。
- 2. 請記住在稅表上報告所有類型的收 人。這對於避免收到國稅局的通知或賬單非 常重要。不要忘記包括以下收入:
- * 在線平台上創建和銷售的商品。

- *投資收入。
- * 自雇或其它商業活動。
- * 通過移動應用程序提供的服務。

3. 以電子方式報稅並使用經轉賬直接存 款是獲得退稅的最快方式。避免使用紙質稅 表。稅務軟件可以幫助個人通過數學計算避 免錯誤。它使用問答形式指導人們完成稅表 的每個部分。

對於那些正在等待處理 2022 年稅表的 人,這里有一個特別提示,以確保其 2023 年稅 表被國稅局接受和處理。請確保在2023年稅 表上輸入去年調整後總收入 (AGI) 爲 0 美元 (零美元)。其他人則應該根據去年的稅表來輸 入上一年的調整後總收入。

4. 免費資源可幫助符合條件的納稅人在 線申報。合格的納稅人也可以獲得免費幫助。 國稅局 Free File 提供了一種提交紙質稅表的 免費在線替代方式。國稅局 Free File 適用于 2023 年收入不超過 79,000 美元的任何個人 或家庭。

領先的稅務軟件供應商與國稅局有長達 稅人。國稅局在 IRS.gov

21年的合作夥伴關係, 通過國稅局 Free File 免費提供其在線産品。今年,有八種英文産品 和一種西班牙文産品。納稅人必須通過國稅 局網站訪問這些産品(英文)。

收入超過 79,000 美元的人可以使用國 稅局的免費報稅可填寫式表格(英文)。這些是 國稅局紙質表格的電子版本。該産品最適合 那些能夠輕鬆自行報稅的人。

合格的納稅人還可以通過免費報稅服務 (VITA) 和老年人稅務輔導 (TCE) 項目在全 國範圍內找到免費的一對一報稅幫助。

5. 考慮使用哪種報稅選項; 每種方式都 有各自的優勢。納稅人應根據自己的個人情 况和報稅的舒適度來決定。

- * 自行報稅。
- * 使用在線報稅服務。
- * 聘請稅務專業人士。認眞選擇稅務專業人 士。大多數代報稅人都是專業、誠實的,並爲

客戶提供優質的服務。 然而,確實存在提交虛假 所得稅表的不誠實代報



息。 6. 無需致電國稅局在線等待。請使用

及有關選擇稅務專業人士的更多信

IRS.gov 上的在線資源獲取稅務問題的解答 (英文)、杳看退稅狀態(英文)或繳稅。無需等 待或預約一在線工具和資源全天 24 小時可 用。國稅局的交互式稅務助手工具 (英文)和 "讓我們幫助您"資源尤其有幫助。
