Ohio Governor Mike DeWine joined leaders from The Ohio State University Wexner Medical Center to announce that the Robert F. Wolfe and Edgar T. Wolfe Foundation has made a \$50 million commitment to the hospital's new tower, set to open in 2026.

They preferred to be a quiet force for good with lasting impact," Governor DeWine said. "I think John F. Associations representing Ohio's education and technology communities from across the state shared their support for the AI Toolkit launched by Ohio Lt. It also provides resources that help promote student privacy, data security, ethics, and other factors.

Governor DeWine and Ohio Department of Aging Director Ursel J. McElroy announced the launch of the Ohio Nursing Home Quality Navigator – a new online tool that provides users detailed information about nursing homes across the state in one convenient digital location.

A recommendation of the Governor's Nursing Home Quality & Accountability Task Force, the Navigator includes a searchable map of all active nursing homes in Ohio with care quality metrics, facility comparison functionality, and other features, such as staffing ratios, specialty services offered, and the number of health and safety violations a nursing home received. The tool is designed to empower Ohioans when considering a nursing home for themselves or a loved one.

"Amending rules to focus bets on the team and away from individual athletes will improve the marketplace in Ohio and proper ly focus betting attention on the teams and away from individual student athletes."

Three-star councils implement many quality practices throughout the year to create a culture of career-focused opportunities for all students.



Two-star councils implement few quality practices and/or show insufficient evidence of implementation. Some quality practices are present; however, there is room for growth in implementation.



One-star councils are in the beginning stages of implementing quality practices or implement very few quality practices.
