Beck Center Awarded \$20K Arts Education Grant PNC Grow Up Great to Fund Early Childhood Programming

Lakewood, OH - Beck Center for the Arts has been awarded a \$20,000 grant from The PNC Foundation's Grow Up Great initiative, a \$350 million, multi-year campaign that began in 2004 to help prepare children from birth to age 5 for future academic success. This funding will be used to provide early childhood arts education programming for preschoolers enrolled in the West Side Ecumenical Ministry's Youth and Family Learning Center (WSEM-YFLC) Head Start as well as The Mary W. Butler Day Care Center at Merrick House in Tremont.

"Studies have proven that an arts-rich environment helps children succeed in school and in life," said Paul Clark, PNC regional president for Cleveland, speaking on behalf of The PNC Foundation. "Our support of Beck Center's renowned programming represents a commitment to furthering school readiness through the arts and ultimately to fostering a stronger community."

The PNC Foundation grant will allow Beck Center to offer weekly arts experiences over a 38-week period involving over 200 Head Start students ages birth to five years. "It is an incredible honor to once again receive this support from The PNC Foundation," said Ed Gallagher, MT-BC, Beck Center's director of education, who will oversee the project. "We are thrilled to be granted this opportunity to bring dance, music, theater, and visual arts into classrooms served by WSEM and Merrick House." Programming begins in September 2012 and continues through the school year, concluding in

May 2013.

Also next school year, Beck Center will continue its collaboration with the Lakewood Child Care Center by hosting an early childhood professional development day at the LCC Center in early June 2013. The day's activities will include a presentation and early childhood concert by Grammy Award-winning musicians Cathy Fink and Marcy Marxer, better known as the well-loved musical duo, Cathy & Marcy. "Once again, Grow Up Great will make it possible for the participating organizations to work together to provide developmentally appropriate and best-practice programming for young children in need," continued Gallagher.

成功的故事

- 奧巴馬總統姑媽遞解出境開案 2008 年 12 月申請, 2009 年 1 月獲准重審, 2010 年 5 月政府獲准, 2011 年 7 月 25 日申請 I-485, 2011 年 9 月 29 日綠卡獲准。
- 1. 夫妻年齡相差 20 歲, 公民先生曾婚 3 次, 太太廣州問話被拒後找到我們。重新申請 130 兩個月批准, 又三個月後廣州問話通過。
- 2. 太太政治庇護 2005 年獲批准後兩年內未幫先生申請 I-730。2010 年申請和上訴均被拒。2011 年 6 月重新申請 10 月批准。
- 3. 中國記者申請政治庇護, 紐約移民局問話獲批准, 前後歷時兩個月。
- 4. 太太 94 年自動離境, 95 年偷渡回美, 先生偷渡有 I-94 還有犯罪記錄。用太太的公民父親 130 申請夫妻倆人綠卡, 太太 6 個月獲批准, 先生 9 個月獲批准。
- 5. 先生用假護照入境被拒, 用公民太太申請綠卡 I-485 問話後申請 601 豁免, 僅 20 天批准並獲綠卡。
- 6. 留學生意外懷孕, 與先生有一個孩子在國內, 申請政治庇護, 兩個月獲批准。
- 7. 太太入境有 I-94, 公民先生申請綠卡, 被移民局誤拒, 申請 I-485 開案, 兩個月批准後再問話獲准。
- 8. 某先生輸了庇護申請上訴也遭拒絕後他聘請我們為他的庇護重新開案, 2011 年 5 月開案成功。
- 9. 我們的客戶是緬甸公民。他輸掉了他的庇護申請案, 提出上訴申請也遭到拒絕。他聘請我們黃唯律師樓, 為他的庇護重新開案。在美國法規基礎上我們準備了詳細的議案, 並提交證明文件。2011 年 5 月移民上訴委員會接受重新開案。案件被重新送回移民局法庭, 使我們的客戶可以繼續他的庇護申請。
- 10. 她的庇護申請被拒絕後, 找到我們黃唯律師樓。客戶是中國公民與美國公民結婚, 在美國有兩個孩子。但是她沒有資格來美調整狀態, 當我們接手後, 她即將要被遣返, 我們為她申請庇護和撤銷遞解令。因為她在美國已經超過 10 年我們需要的客戶提供大量的證明文件。經過近四個小時的聽證會, 在堪薩斯城的移民法官給予我們的客戶取消遞解並可以保持與她的家人在美國為合法的永久居民。
