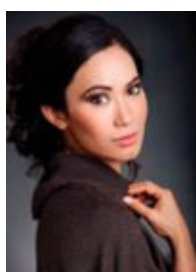

暫緩遞解的有關的條件

- “暫緩遞解”法案於 8 月 15 日生效已有無數的青年向美國公民及移民服務局(USCIS) 提出申請暫緩驅逐在美合法工作, 兩年後可申請延長, 申請人不得離境出國。申請沒有時間限制, 未滿 15 歲的, 可以等滿 15 歲時再提出申請, 申請人只要來美時未滿 16 歲, 無論當初是自行來美, 或是隨父母入境都可申請, 新辦法為鼓勵學習, 即使目前沒有在學, 只要申請時在學即符合資格, 同時申請社安號碼, 駕照, 工卡。
暫緩遞解所需條件:
1. 16 歲生日以前入境美國
2. 在 2012 年 6 月 15 日沒超過 31 歲生日
3. 合法或非法人境
4. 現在沒有合法身分
5. 從 2007 年 6 月 15 日到 2012 年 6 月 15 日人在美國, 目前仍然在美國
6. 目前在學校就讀, 高中畢業, 已獲得普通教育發展證書, 或從海岸警衛隊或美國武裝部隊 光榮退伍的老兵
7. 沒有被裁定犯重罪, 一個重要的輕罪犯罪, 多個輕罪犯罪, 或以其他方式構成威脅國家安全或公共安全的
