他們家經營的餐館 Ang's Asian Cuisine 里發 現了孩子的屍體。

警方目前已確認:5 歲女孩 Ashley 周一早 上 9:15 就已經死亡,造成孩子死亡的是她媽 媽,29 歲的陳明明(Mingming Chen)用暴力擊 打孩子的臉部多次,導致孩子死亡。而她 34 歲 的丈夫趙良 (Liang Zhao) 女孩的父親被指控

犯有共謀罪。

事情的經過按法庭文件顯示,孩子被母親 暴打之後,嘴角流出了"緑色的液體 (green fluid)",父親把孩子抱到浴室把液體擦乾凈,試 圖使孩子甦醒過來。父親使用 CPR(心肺復甦) 但沒有成功, 孩子已經停止了呼吸。
