近日網上流傳一份兩頁紙文件, 號稱是川普政府正在 起草中的行政命令,被網友稱爲"史上最強的緑卡移民申請 福利改革",嚇得移民社區很多緑卡持有者不知所措。法界人 士認爲,川普的"恫嚇"不太可能成眞,但過去曾經爲親屬移 民緑卡提供擔保的美國公民,必須要注意

該文件表示,未來將禁止緑卡持有人領取福利,成爲公 共負擔(public charge),被禁止的福利除現行規定的現金援助 (SSI,TANF 或州和地方政府的現金援助)外,還會新增糧食 券、聯邦醫療(Medicaid)、兒童健康保險(CHIP)、緊急醫療服 務、婦女、嬰兒、兒童補助(WIC)、其它營養、食品幫助,學童營 養午餐、甚至職業培訓、能源補貼、教育幫助等福利。文件稱, 一經發現有緑卡移民申請任何低收入者領取的福利,其生活 保證人將負責償還公費開支。

據美國移民法律與移民局(USCIS)手冊,親屬移民若成 爲"公共負擔",即不能再入境或調整身分,還可被遣返。公共 負擔是指,移民要仰賴政府現金援助維持收入,或是聯邦資 助的長期醫療服務

移民律師表示,移民圈一直傳説川普政府會出台移民 新政策,但他不認爲這份傳説的行政命令是眞的。"公共負 擔"是正式的法律定義,總統不可能靠行政命令去修改法律 定義,不能隨意新增一些項目作爲"公共負擔"。不過他認爲, 川普可以靠行政命令將民衆領取補助的過程弄得複雜繁瑣, 例如每隔一個月就必須更新近况,重新申報一次,減少申請

移民律師表示,公共負擔的議題主要針對用親屬移民 來美的人,而他們在申請移民時都有美國公民作保證,"一旦 他們有拿美國福利,擔保人將負責償還這筆費用"。所以,若 緑卡持有者確實有拿政府福利,其擔保人有可能需還債。此 外,什么福利可以拿,什么福利不能拿,也不容易界定。因爲很 多州政府給的福利經費來自聯邦,聯邦也有可能會追究。

從川普 2017 年上任開始,移民社區一直感到恐慌。以 舊金山"新鮮食物計畫"(Calfresh,前身爲糧食券)爲例,全市 應有10萬人(家庭)符合申請資格,但只有一半人申請,還有 一半人似乎不敢申請,而且每個月都有上百戶家庭退出申請 計劃,導致舊金山社會服務局局長羅勒(Trent Rhorer)認爲,這 與川普的移民政策有關,他推測很多人可能擔心拿了福利之 後會對移民造成影響。其實移民社區對"新鮮食物計畫"有 許多誤解,它不屬於"政府福利",申請人向移民局提出移民 申請時,無須塡報"新鮮食物計畫",不對移民申請造成任何

此外,申請白卡的人數也在減少。以紐約爲例,全市有三 分之一居民用白卡支付看醫師、去醫院、請家庭護理。但從 去年開始,申請人數驟減,因爲很多移民擔心,申請白卡會被 視爲吃政府福利,導致收到罰單甚至被遣返。

在北加州,一些華人合法移民,因爲擔心接受某些醫療 保險計畫成爲公衆負擔被遣返,在看病時只付現金。儘管移 民團體一直鼓勵符合條件的移民別懼怕申請白卡,但大家的 擔憂仍然未消失。

Dr. Mihaljevic's route to Cleveland Clinic's top office took him from Croatia, to Switzerland, to Boston, to Cleveland, to Abu Dhabi, and now back to Cleveland.

Born in Zagreb, Croatia - then part of communist Yugoslavia - Dr. Mihaljevic earned his medical degree at Zagreb University. Because his family was anti-communist, his job options were limited. Dr. Mihaljevic volunteered where he could, and found work as a nurse assistant.

"I've done all the worst possible jobs you can have in a hospital," he says. "I wouldn't trade that experience for

He was accepted into the graduate program at Zurich University in Switzerland, where he trained with Marco Turina, MD, a leading cardiac surgeon in Europe. In 1995, out of a pool of 600 applicants, Dr. Mihaljevic was one of the five in Boston.

Dr. Mihaljevic went on to become an associate surgeon in the Division of Cardiac Surgery, Director of the Cardiac



professor of Surgery at Harvard Medical School. During much of that time, he was being recruited by Dr. Cosgrove to join Cleveland Clinic. In 2004, he joined the staff of Cleveland Clinic's No. 1-ranked

In 2010, he accepted Dr. Cosgrove' s invitation to join the soon-to-be-opened Cleveland Clinic Abu Dhabi as Chief of Staff and Chair of its Heart & Vascular Institute. He led a recruitment effort there that drew 5,500 applications for 175 physician posts, and he went on to launch the most advanced cardiovascular program in the Middle East.

As CEO of Cleveland Clinic Abu Dhabi from 2015 to 2017, he oversaw the opening in 2015 of the 365-bed hospital
