Ohio Requires General Motors to Refund Tax Incentives Following GM Lordstown Plant Closure Action includes repayment of \$28 million in tax credits, \$12 million community investment.

(COLUMBUS, Ohio) — The Ohio Tax million in the local Credit Authority today approved a recommendation by the Ohio Development Services Agency to terminate the Job Creation and Retention Tax Credit agreements with General Motors following the company's decision to close its Lordstown assembly facility.

General Motors will be required to invest \$12 million in the Mahoning Valley by the end of 2022, and refund \$28 million in tax credits. In 2008, the company entered into Job Creation and Retention Tax Credit agreements which resulted in the issuance of \$60.3 million in tax credits.

"GM has been a major employer in the state of Ohio for decades, investing in both the economy and our workforce. While the decision to close the Lordstown plant was terrible news for workers and their families in the Mahoning Valley, today's announcement will bring relief as well as investment by GM who has committed to investing \$12

community workforce, tion, and infrastructure needs," said Governor Mike DeWine. "GM has also committed to returning \$28 million to the state for the job creation and retention credits they were awarded. GM remains involved in

auto production in Lordstown to produce batteries for electric vehicles which is also good news for the future of the automotive industry."

"Ohio has a long and proud history with General Motors," said Lt. Governor Jon Husted. "When I spoke with GM on Friday to confirm



to Ohio, I emphasized our desire for Ohio to be the place where they invest in their future and that we would be a reliable partner in providing the workforce and business environment they will need to compete and succeed."

General Motors was approved for a Job Retention Tax Credit in exchange for a commitment to retain 3,700 employees in Lordstown. The company did not maintain its commitment to retain the jobs through 2028.

General Motors has other state incentives for its operations in Toledo and Defiance. The company is currently compliant with those agreements. Following today's decision by the Ohio Tax Credit Authority, the issue will now be turned over to the Ohio Department of Taxation per the Ohio Revised Code.

全美召回! 華人最愛的 這樣食物出事了, CDC 發 緊急排查通告!

美國多州爆發了沙門氏菌感染。10個州共有41人不適,其中4人住院。

在疾病控制與預防中心(CDC)和食品及藥物管理局(FDA)的合力調查下,懷疑此次事件與Shirakiku 牌中國産黑木耳有關。

目前食品管理部門已經發佈通知,要求發售該木耳的 Wismettac 亞洲食品有限公司召回此次產品。

但因爲該産品已運送到 31 個州和華盛達 特區的餐廳,所以 FDA 建議消費者光顧餐廳時, 可向服務員詢問食物來源,避免吃到有問題的黑 木耳。

美又要撒錢,新紓困 金還是 1200 美元,

據 CNBC 報道,繼民主黨人公佈了一份新的紓困方案後,周二國會衆議院議長佩洛西和財長姆努欽就此重啓對話。

民主黨人公佈了了一份 2.2 萬億的紓困方案,試圖打破和白宮之間維持數周的僵局。

今年五月民主黨曾推出的 3.4 萬億的 方案,但川普政府只希望再注入 1.3 萬億支持經濟和疫情下的醫療看護系統。

兩者相差甚遠, 也導致最終幾個月來, 雙方陷入僵持。

衆議院議長髮言人 Drew Hammill 表示,周二早間,佩洛西和姆努欽進行了 50 分鐘的通話,溝通了最新一版方案的修改之處。

雙方預計周三將再度通話,但是目前 尚不清楚雙方是否距離達成妥協進了一步。 佩洛西表示,民主黨人砍掉了原本方 案的1萬億,這是"極大的妥協"。新的方案 將包括:

- 恢複 600 元的聯邦額外失業補貼直到 明年 1 月 - 再向大部分美國人發 1200 元紓 困款 - 未來一年向州和地方政府撥付 4360 億元的財政補貼 - 向 PPP 小商業貸款項目 撥付更多錢 - 向航空公司撥付 250 億用于 支付員工薪酬 - 撥款 750 億用于新冠病毒 的檢測和密切接觸者追踪 - 撥付 2250 億用 于教育、570 億用于兒童看護 - 留出數十億 給租金和貸款支持?

這些條款當中,共和黨人強烈反對再給 各州和地方政府更多補貼。

而白宮提議給各州和地方 1500 億財政支持,遠低於民主黨的方案。

不少共和黨人對再補貼數萬億資金錶 示擔憂。

本月早些時候共和黨把持的參院試圖 通過一份約 5000 萬的救濟方案但被民主黨 人否決,稱該方案"不充分"。

即便在總統川普提名最高法院大法官 人選之前,新一輪紓困案之中的兩黨博弈就 異常激烈,市場對於11月3日總統大選前 能否通過新一輪財政刺激措施充滿疑慮。
