You will have to provide invoices or receipts for whatever you put this money towards (rent, property taxes, inventory, utilities, etc).

Also, Destination Cleveland (our local tourism agency) is running a campaign - CLEAN COMMITTED. You can commit to their standards (which many of you are already doing). They will send kits for your customers with individually packaged hand sanitizer packets and masks (CLEAN KITS) along with marketing materials that you can hang in your businesses. Register here.
