#### HOUSING **New Actions on Housing**

On Wednesday, June 26th, Vice President Harris announced first-of-its-kind funding to lower housing costs by reducing barriers to building more homes.

Vice President Harris announced the recipients of new grants under the Pathways to Removing Obstacles to Housing (PRO Housing) grant competition with the goal of building more housing, and lowering housing and rental costs for American families. This announcement builds on sweeping actions to reduce barriers, boost housing supply, and lower costs, including:

- \* Leveraging discretionary grant programs to encourage state and local action to build more housing.
- \* Updated guidance for converting commercial property to housing.
- \* Provided low-cost capital for housing.
- \* Finalized the Low-Income Housing Tax Credit (LIHTC) "Income Averaging" rule.
- \* Streamlined and modernized the HOME program.
- \* Invested in making our nation's affordable housing more energy efficient and resilient. (go to page 17)


